## THE DEPARTMENT OF ATTORNEY GENERAL'S THIRD STATUS REPORT FOR DECEMBER 19, 2017

On November 29, 2017, the Superior Court, Stern, J., issued an Order requiring that the Rhode Island Department of Attorney General (hereinafter "Attorney General") provide weekly status updates to Special Counsel and the Court on the status of the Attorney General's efforts to comply with the subpoena served on the Attorney General on November 3, 2017 (the "Subpoena"), the first report was provided on December 5, 2017 and subsequent status updates are required every 7 days thereafter.

On December 12, 2017, the Attorney General filed a Second Status Report. On December 13, 2017, the Attorney General filed a Supplement to the Second Status Report. The within report will update the Court through December 19, 2017.

The Attorney General has taken the following action in compliance with the Subpoena as of December 19, 2017:

 On December 13, 2017, WarRoom delivered an additional five (5) boxes. These boxes reflect documents as they are maintained in the ordinary course of business, and more specifically, contain documents related to the 2014 Hospital Conversions Act Proceedings. - 2. On Monday, December 18, 2017, WarRoom delivered another five (5) boxes of documents, containing documents related to the 2014 Hospital Conversions Act Proceedings. Rolling production of boxes from WarRoom will continue this week with an additional five (5) boxes estimated for delivery by the end of the week. Once that delivery is received, we will have twenty (20) of the twenty-nine (29) boxes returned from WarRoom.
- 3. On December 18, 2017, the Attorney General delivered to Special Counsel the following two (2) boxes of documents with logs identifying privileged and confidential documents as necessary:
