The Roman Catholic Bishop of Providence, a corporation sole ("RCB"), files this status report regarding its response to the November 2, 2017 subpoena ("Subpoena") served by special counsel to the court-appointed receiver ("Special Counsel") in the above-referenced proceedings.

1. On January 12, 2018, RCB produced an additional 1,057 pages. The production

consisted of (a) responsive documents resulting from the additional search efforts described in RCB's December 18, 2017 correspondence to Special Counsel, (b) privileged documents that RCB determined could be produced with redactions, and (c) documents produced in light of the meet and confer process.
