For all of the above reasons, Churchville respectfully requests an additional 30 days to submit a response.



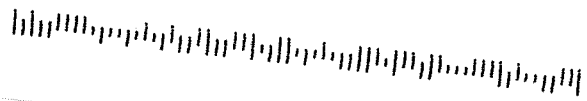
