THE DEPARTMENT OF ATTORNEY GENERAL'S
EIGHTH STATUS REPORT

On November 29, 2017, the Superior Court, Stern, J., issued an Order requiring that the Rhode Island Department of Attorney General (hereinafter "Attorney General") provide weekly status updates to Special Counsel and the Court on the status of the Attorney General's efforts to comply with the subpoena served on the Attorney General on November 3, 2017 (the "Subpoena"). On January 19, 2018, the Attorney General filed the Supplement to the Seventh Status Report. The within report will update the Court through January 23, 2018.

The Attorney General has taken the following action in compliance with the Subpoena as of January 23, 2018:

1. On Tuesday, January 16th, the Attorney General filed a Motion and Memorandum in Support to Extend Time to Respond to Requests 1 and 3 of the Subpoena for an additional Ten (10) Days (the "Motion").
2. On Friday, January 19th, the Attorney General filed its Supplement to the Seventh Status Report stating that the hard document and ESI production had been completed, with only production of the privilege log for the Electronically Stored Information ("ESI") remaining, which would include the emails and/or documents resulting from the identified custodians and search terms proposed by Special Counsel.

3. On January 22nd, the Court heard the Motion, which was granted, allowing the Attorney General an additional ten (10) days or until Friday, January 26, 2018 to produce privilege logs for the ESI.

4. In an effort to provide one comprehensive privilege for all such responsive ESI, the Attorney General is collecting all of the privilege logs created by reviewing attorneys and merging those logs into one complete log for the benefit of Special Counsel. The ESI privilege log will be produced on or before Friday, January 26, 2018.
