


THIRD ANNUAL PRO BONO & COMMUNITY SERVICE AWARDS

Among the ways we work to encourage pro bono and community service as part of our firm culture is to recognize those in our firm who have made outstanding contributions to our communities and our firm. Our Third Annual Pro Bono & Community Service Awards Ceremony, held on January 25, 2017, recognized the efforts of our attorneys and staff in 2016.

McKusick Community Impact Award

Named after Vincent Lee McKusick, former Chief Justice of the Maine Supreme Judicial Court and Pierce Atwood friend and lawyer for more than 50 years, the McKusick Community Impact Award recognizes one attorney and one staff member annually who have made significant, positive impacts in their communities through pro bono and/or community service. Award recipients select a charitable organization to receive a monetary donation made on their behalf by Pierce Atwood.



Tony Derosby, partner in the Immigration Practice Group in Pierce Atwood's Portland office, was honored for his work with Immigrant Legal Advocacy Project (ILAP), his ongoing mentoring of ILAP volunteer attorneys and for offering immigration workshops. Pierce Atwood has a long-standing relationship with ILAP, which provides affordable legal services and collaborates with service providers, policymakers, and the public concerning legal issues unique to immigrants, to ensure immigrants can effectively navigate Maine's legal system. ILAP helps immigrants gain or improve their legal status, unites families, improves educational and employment opportunities, and helps them contribute fully to their new communities in Maine.

Karen Bean, a legal assistant in the Portland office, was recognized for her work with Girls on the Run. Girls on the Run works with girls ages 8-13 to inspire them to be "joyful, healthy, and confident, using a fun, experience-based curriculum that creatively integrates running."



Scribner Firm Impact Award

Named after long-time former partner Fred Scribner, whose legacy endures through the firm's commitment to the community, its employees, and the law, this award is given annually to one attorney and one staff member who work to keep pro bono and community service top of mind throughout the firm.

Ron LaRocca, a litigation associate in the Providence, RI office, was selected for his ongoing work with Kids in Need of Defense (KIND) and the Rhode Island Volunteer Lawyers Project (RI VLP), as well as his tireless dedication to providing legal assistance to the family of a Pierce Atwood employee who lost her life under tragic circumstances.





Mary Clifford, a legal assistant in the Portland office, has been the "heart and soul" behind the Portland office's annual Day of Community Service since 2010. Each year, Mary contacts potential organizations to determine if they have a need for our volunteers. As participation has grown, this involves finding multiple organizations and a mutually convenient date, ensuring a variety of work of varying physical requirements to accommodate the broadest number of participants, forming the work groups for each location, and finding a leader for each group.

Firm colleagues recognized Mary for "always giving her best, wanting things to be perfect, and caring from her heart!"

Pro Bono Attorney of the Year

This award is presented to the attorney who has contributed the highest number of pro bono hours in a year.

Griff Leschefske, a Trusts & Estates associate in the Portland office, completed 313 hours of pro bono service in 2016, providing assistance to Court Appointed Special Advocates (CASA), Maine VLP, and several individuals, families, and nonprofit organizations.

Pro Bono Successes

Citizenship Workshops

The **Immigrant Legal Advocacy Project (ILAP)** partnered with Pierce Atwood to offer Citizenship Workshops at our Portland office in May and November.



Each workshop started with a one-hour orientation and training program for participating Pierce Atwood attorneys, covering the basic eligibility requirements for citizenship, the application and forms, and the required supporting documentation for the citizenship application. As the ILAP clients began to arrive, the Pierce Atwood attorneys were paired with applicants and, with the support of ILAP attorneys and staff, helped the ILAP clients prepare applications for naturalized citizenship and related supporting documents. The ILAP clients all are low-income lawful permanent residents who meet the legal requirements to become citizens of the United States but require assistance with preparing an application for naturalized citizenship. The goal of the workshops is to help these applicants finalize the necessary paperwork for filing with United States Citizenship and Immigration Services (USCIS).

Over the course of these two workshops, 24 Pierce Atwood attorneys and paralegals worked together to help 21 ILAP clients complete applications for naturalized citizenship.

Bar Leadership Recognition

Pierce Atwood associate Nick Brown was selected for the **Boston Bar Association's Public Interest Leadership Program** (PILP), a 14-month program that "promotes civic engagement and public service by advancing the leadership role of lawyers in service to their community, their profession and the Commonwealth."

With the goal of getting younger lawyers to become more engaged as community leaders earlier in their careers, the selective program brings together lawyers from a variety of law firms and practice settings who have demonstrated a commitment to public service and pro bono work. The participants learn from judges and other community leaders in the Boston area, working together on a public interest project of their choosing, and developing relationships that will benefit them throughout their careers.



Pro Bono Successes

Helping to Pave the Way

Working with staff counsel from Gay & Lesbian Advocates & Defenders (GLAD), Pierce Atwood attorneys **Mike Daly** and **Katie Kohm** played a key role in convincing the Rhode Island Family Court to recognize the non-biological mother in a same-sex relationship as the parent of a child conceived through in vitro fertilization (IVF) using sperm donated by an anonymous donor. The case began as an adoption petition, but the court clerk refused to schedule hearing on the petition without our client first publishing notice in a newspaper in Virginia, where the sperm was donated. We were originally asked to work with GLAD to help develop a strategy and argument to convince the court to dispense with this unnecessary, cumbersome and expensive publication requirement.





In making the argument, we went a step farther and asked the court to declare the non-biological mother to be a de facto parent, which would make the adoption unnecessary and the publication issue moot. The judge agreed. This is the first time the Family Court has applied the "de facto parent" concept to allow a same-sex couple to establish parentage for the non-biological parent of a child conceived through IVF. Previously, the concept had been applied to same-sex couples only in the context of disputes over custody following a divorce or break-up. This decision will help pave the way for same-sex couples looking to start a family in Rhode Island.

Help in a Time of Need

Pro Bono Successes

Securing Home & Family

After nearly a year of work on a guardianship and eviction case, Pierce Atwood attorney **Ron LaRocca** was able to secure housing for VLP client "A" and guardianship for her niece "K" following a hearing in Pawtucket, Rhode Island Probate Court. Twelve-year old K's mother died in 2013, and she had never known her father. Without anywhere to live, A took K into her home in public housing rather than see her niece go into state custody. The Pawtucket Housing Authority threatened to evict A and her family because she did not have any legal authority over K's care. The Rhode Island Volunteer Lawyer Program asked Ron to step in to protect A's housing and assist her in obtaining guardianship over K.



The case took a variety of twists and turns. After obtaining A's appointment as temporary guardian, it was necessary to learn the identity and location of K's father (unknown to A and K), in order to secure his agreement to the appointment of a permanent guardian. It was found he had passed away in 2015. With no biological parent living, this cleared the way for the Probate Court to appoint A as K's permanent guardian. A's home is now secure and K finally has an adult legally responsible for her care and upbringing.

Fundraising Successes




Meg LePage served as the **2016 Chair of The Maine Justice Foundation's Campaign for Justice**, which raises funds for six of the state's civil legal aid providers – Immigrant Legal Advocacy Project, Maine Volunteer Lawyers Project, Pine Tree Legal Assistance, Maine Equal Justice Partners, Legal Services for the Elderly, and the Cumberland Legal Aid Clinic of the University of Maine School of Law. Meg was responsible for leading the campaign of about 100 volunteer attorneys statewide.

The total raised in 2016 under Meg's leadership: a record-breaking **\$602,357**!

Jack Sanders serves as **Chair of the Leadership Council of the Campaign for Legal Services**, the fundraising arm for New Hampshire Legal Assistance and the Legal Advice and Referral Center, both of which provide civil legal services to the poor.

2016 marked two important anniversaries: the 45th year since New Hampshire Legal Assistance was formed from the merger of two smaller organizations, and the 20th year since the formation of the Legal Advice and Referral Center.

Under Jack's leadership, the 2016 Campaign for Legal Services raised a total of **\$294,000** – 107% of their \$275,000 goal.



Community Recognition



In the year ending June 30, 2016, 14 Pierce Atwood attorneys (pictured below) earned distinction as Katahdin Counsel.













Community Service

As a firm, we hold an annual **Day of Community Service**. Since 2004, our attorneys and staff leave the office together to work on service projects for deserving charitable organizations. Our 2016 projects included:

Boston Day of Community Service - October 5, 2016

Our Boston office team volunteered with **The Esplanade Association**, which, in partnership with the Massachusetts Department of Conservation, works to restore and enhance Boston's Charles River Esplanade. Wielding large loppers and hand-sized trimmers, attorneys and staff spent the morning removing non-native invasive plants and bushes from about a quarter-mile stretch of riverbank.



Through **our Janet D. Eustis Memorial Staff Volunteer Time-Off Program**, launched in 2014, staff members are given one paid day off each year to volunteer for a nonprofit organization of their choice.

In 2016, 18 staff members participated in the program, volunteering approximately 86 hours of their time in their communities.

At the **Maine Society for the Protection of Animals**, our volunteers assisted with various barnyard chores, including cleaning the horse stalls and other barnyard areas.

Another Pierce Atwood team at **Westbrook Community Center Trails** spent the day raking, hauling, limbing, filling and planting, while additional projects were completed at the Westbrook Community Center.





Charitable Giving

In 2016, our Charitable Giving Committee chose the **Travis Roy Foundation** to benefit from our collaborative fundraising efforts.

Travis grew up in Yarmouth, Maine and started his freshman year at Boston University in 1995. He was eleven seconds into his first collegiate hockey game when he crashed into the boards the wrong way and was left paralyzed from the neck down. The foundation he created following his injury is focused on empowering spinal cord injury survivors through adaptive equipment grants, and also provides funding for spinal cord injury research. Today, along with his Foundation work, Travis is a popular motivational speaker and makes frequent appearances in and around New England and across the country.

Our firm-wide fundraising efforts in support of the Travis Roy Foundation included:

- "Jeans Fridays" on the first of each month, when, in exchange for a \$5 donation, Pierce Atwood employees are allowed to wear jeans to work
