**ORDER APPROVING SUCCESSOR LIQUIDATING RECEIVER'S FIRST INTERIM REPORT
AND ACCOUNTING AND REQUEST FOR APPROVAL OF FEES, COSTS AND EXPENSES**

This matter having come on for WebEx Hearing on December 8, 2023, before the Rhode Island Superior Court sitting for Providence County, the Honorable Judge Brian Stern presiding, on the Successor Liquidating Receiver's First Interim Report and Accounting and Request for Approval of Fees, Costs and Expenses (the "First Report"), by Stephen F. Del Sesto, Esq., Successor Liquidating Receiver herein. The Court being satisfied that Notice of said Hearing has been given to all interested parties and creditors of the Respondent as set forth in the Affidavit of Notice filed by the Receiver relative to said First Report, it is hereby

ORDERED, ADJUDGED AND DECREED:

1. That the First Interim Report of Stephen F. Del Sesto, Esq., in his capacity as Successor Liquidating Receiver herein, and all acts, doings, and disbursements of said Receiver to date are hereby approved, confirmed and ratified;
2. That the fees, costs and expenses incurred and billed by the Receiver from the commencement of the Successor Liquidating Receiver's appointment through and including November 30, 2023 (the "Invoice Period") are fair and reasonable;
3. That the Receiver's First Interim Request for fees, costs and expenses incurred during the Invoice Period in the amount of \$49,938.13 are all hereby approved in full and the Receiver is authorized and directed to pay himself in full from available sources of cash in or held by the Estate;

4. That the Second Interim Report and Request for Fees of the Successor Liquidating Receiver will be scheduled for WebEx hearing in March 2024 at a date and time to be docketed; and

5. That this matter shall remain open and the Order Appointing Receiver entered herein shall remain in full force and effect until further Order of this Court.
