1	Maine	Annual registration fee due for any facility that is subject either to Chemical Inventory Reporting or Toxic Release Inventory reporting.
1	Maine	Beginning of fall season for dune restoration or construction under NRPA permit by rule.
1	Maine	Deadline for consolidators of electronic waste to submit annual report to DEP covering operations for the previous July 1 to June 30.
1	Maine	Deadline for toxics users, toxics releasers, and hazardous waste generators to pay annual priority toxics chemical law fees.
1	Maine	For facilities in municipalities beginning with M-Z, owners of USTs used for storage of motor fuel or marketing and distribution of oil must report results of annual statistical inventory analysis for each tank to the DEP.
1	New Hampshire	Deadline for Community Water Supply owners to certify to DES that the Consumer Confidence Report has been distributed to customers and that the information is correct and consistent with compliance monitoring data.
4	Federal	Deadline for kraft pulp mills for which construction, reconstruction, or modification began after May 23, 2013, that are required to install a continuous monitoring system, and that are subject to new source performance standards to submit a semiannual excess emissions report.
15	Maine	Each owner or operator of a facility subject to toxic chemical release reporting requirements under 40 CFR 372 must submit revisions to Form R data previously reported if the owner or operator wishes publicly available data to reflect those revisions.
15	New Hampshire	Deadline for owners and operators of NOx-emitting generation sources subject to NOx Emissions Reduction Fund to pay the quarterly fee for prior quarter.
15	New Hampshire	Deadline for owners and operators of stationary sources, area sources, or devices having actual annual emissions less than 1,000 tons to pay the annual emission-based fee.
15	New Hampshire	Deadline for owners and operators of stationary sources, area sources, or devices having actual emissions greater than 1,000 tons to pay quarterly emission-based fee.
30	Federal	Deadline for units subject to the continuous emission monitoring provisions of the acid rain program to submit a quarterly report electronically to EPA.
30	Federal	Deadline for any person allocated an essential-use allowance under 40 CFR 82.4(n) and who orders a controlled substance from a producer or importer to submit a quarterly report to EPA.
30	Federal	Deadline for producers of a Class II controlled substance under the Montreal Protocol to submit a quarterly report to EPA.
30	Federal	Deadline for all nitrogen oxides annual units subject to the Transport Rule in operation prior to July 1, 2011 to submit a quarterly report to EPA.
30	Federal	Deadline for all units subject to the nitrogen oxides ozone season trading program under the Transport Rule in operation prior to July 1, 2011 to submit quarterly report to EPA.
30	Federal	Deadline for all sulfur dioxide Groups 1 and 2 units subject to the Transport Rule in operation prior to July 1, 2011 to submit quarterly report to EPA.
30	Maine	Air emissions quarterly reports are due to DEP and, for NSPS sources, to EPA.
30	Maine	Owners and operators of fossil-fuel fired steam generating units subject to NSPS for electric utility steam generating units and for industrial-commercial-institutional steam generating units must submit quarterly reports for sulfur dioxide, nitrogen dioxide, and opacity emissions by this date.
30	New Hampshire	All NOx budget sources must report their control period emissions to the NETS administrator by this date.
30	New Hampshire	Deadline for owners and operators of kraft mills subject to the TRS emissions rules to submit an excess emissions report for prior calendar quarter.

30	New Hampshire	New NOx budget sources shall submit a request by this date for allowances from the set-aside account.

30	New Hampshire	Deadline for owners and operators of NOx budget sources to hold a quantity of NOx allowances in the current year NATS account equal to or greater than the total NOx emitted from that budget source between May 1 and September 30.

1	Federal	Deadline to submit quarterly RIN activity report to EPA for any obligated party or exporter of renewable fuel.
15	New Hampshire	Deadline for facilities that undergo frequent Class S major asbestos abatement to file an annual notification and pay an annual fee.
22	New Hampshire	All existing single wall underground storage tank systems without secondary containment and leak monitoring shall be permanently closed by this date.
31	Federal	Deadline to submit annual emissions inventory reports regarding SO2, VOCs, NOx, CO, lead, particulates, and ammonia for all states with regard to large (Type A) point sources.
31	Maine	Submerged lands easement registration fee is due upon execution of the easement and on or before December 31 every 5th year thereafter.
31	New Hampshire	Deadline for facilities that undergo frequent Class S major asbestos abatement and use the annual notification form to file a quarterly report of activities performed.
31	New Hampshire	Expiration date for annual Fish and Game Department permits for imports of controlled wildlife.
31	New Hampshire	Expiration date for commercial aquaculture licenses that have not been renewed.
